### Church, State and Politics in Sixteenth and Seventeenth Century England

Thomas Tanner (1674–1735), author, churchman and indefatigable collector of manuscripts, was one of the key figures in the resurgence of historical and antiquarian research of the later 17th and early 18th centuries. As a Fellow of All Souls College, Oxford, chancellor of the diocese of Norwich and finally Bishop of St. Asaph, he was well placed in both academic and ecclesiastical worlds.

### Early and Central Middle Ages, c.650–1200: The Manuscript Record

Drawn from the superb holdings of Cambridge University Library, this collection of nearly 100 manuscripts from the 7th to the 12th centuries makes possible an extended analysis of learning and literature during this time. These rare and often exceedingly beautiful manuscripts cover the entire period of Old English literature and present the Anglo-Saxon, Latin and other traditions extant in Britain to the end of the 12th century. They include literary, theological and philosophical works, Psalters, lives of saints, charters, gospels, historical miscellanies and bestiaries.

## Ecclesiastical Authority in England: Church Court Records, c.1400–c.1660

Illuminating economic, legal and religious aspects of medieval society, this vital collection provides the working record of ecclesiastical jurisdiction. The collection's earliest prompt copies are from the days of the Theatres Royal, including the rare copy of *Cymbeline* used in David Garrick's version of the play at Drury Lane. The early years of the Shakespeare Memorial Theatre are also covered. The more recent prompt copies document the stage history of the theatres that have seen all the greatest Shakespearean actors, directors and designers of the 20th century.

## **King James I of England to King Christian IV of Denmark: Royal Correspondence, 1603–1625**

From the outset of his reign, King James I (VI of Scotland) tried to ease the troubles between the English and the Danes. The subject matter of these letters to his brother-in-law King Christian IV of Denmark is wide-ranging. The principal

concerns are English trading rights in the North Sea and the problems encountered by both mariners and merchants on the Continent. In general, the letters give new insight into the character and preoccupations of the King.

The 139 original Latin letters are reproduced from the collection housed in the Danish National Library in Copenhagen. They appear together with full English translations and have been edited and introduced by Professor Ronald M. Meldrum, Washington State University.

This eminently useful collection offers 308 well-preserved manuscripts from the medieval library at Pembroke College, Cambridge. Featured are 100 volumes formerly in the Library of The Abbey of Bury St. Edmunds — one of medieval England's leading centers of learning. Received in 1599 by Pembroke College, they constitute by far the greatest surviving nucleus of any of the famed monastic libraries. Many more high-quality volumes from Christ Church, Canterbury, Buildwas, Shropshire and Reading Abbey are included, as well as personal donations by Lancelot Andrewes, Edmund Boldero and William Mundy.

## Property and Privilege in Medieval and Early Modern England and Wales Cartularies from the British Library, London

Cartularies are registers of muniments — the title deeds, charters of privilege and other documents kept by medieval landowners as evidence of their rights. The first cartularies date from the first half of the 11th century when religious houses compiled them, but by the 13th century, secular landowners had also started to produce them. Most of the cartularies were produced in the 14th century, although the practice continued well into the 16th century.

## The Star Chamber and English Society in the Reign of James I: A Subject Selection from PRO Class STAC 8

The Jacobean Star Chamber Proceedings (STAC 8) have long been recognized as a key source for the history of the reign of James I. This selection of the most important documents in STAC 8 has been assembled under the guidance of the leading authority on the Star Chamber, Dr. J.A. Guy of the University of Bristol, and is designed to reflect all aspects of the Star Chamber's work under James I. A major feature of the project is that the documents selected have been filmed by subject, rather than class-code, making the material easily accessible in as coherent a form as possible. The subjects chosen are those defined in the *Legal History Project of the American Bar Foundation, List and Index to the Proceedings in Star Chamber for the Reign of James I* (Chicago, 1975). These important records of country and gentry politics form a valuable complement to those of court and Parliamentary politics, and are a valuable source for the 17th-century historian.

## State Papers (Foreign) of Mary I, 1553–1558

The brief reign of "Bloody" Mary, half sister of Edward VI, was surprisingly eventful for British foreign affairs. Against the wishes of Parliament, Mary married her Roman Catholic cousin Philip II of Spain in 1554. This connection drew her country into a disastrous war against France that resulted in England's loss of Calais, its last possession on the Continent. These and other events make this collection particularly useful for students of British relations with Europe's major powers and of the conflict between Catholics and Protestants.

## State Papers Medieval and Other Records PRO Class SC 1 (Ancient Correspondence, 1175–1538)

The Ancient Correspondence Class is reproduced in its entirety. Spanning the reigns of King John to King Henry VIII, this unique collection includes the correspondence of kings, bishops, popes, knights, noblemen, royal servants and lord's chancellor. Principally assembled from documents formerly held in the Tower of London, the Ancient Correspondence Class is comparable in breadth and detail to the later State Papers series. There are documents hand-written by Stephen Langton, John Gower, Pope Innocent III, most of the English kings and their chancellors, and a wide range of other medieval and early modern figures.

Affairs of state are the predominant theme, but also underscored are ecclesiastical elections, the besieging of castles, the wool trade, piracy on the high seas, the protection of lepers, enclosures, the

keeping of servants and falcons, the presentation of jewels, taxes, safeguards against the invasion of England from France, border wars, royal buildings and local customs. More than 12,400 individual documents make up this substantial collection, which constitutes a major point of reference for all aspects of medieval studies.

## Tudor and Stuart Manuscripts from the Harleian Collection

Robert Harley, Earl of Oxford and Mortimer, was a colorful political figure in 18th-century England. Successively Speaker of the House of Commons and Lord High Treasurer, he was impeached for high treason and sent to the Tower in 1715.

The State Papers Foreign for the period 1592 to 1603 -- a central source for English and European history -- are totally uncalendared and have until now only been available by personal visit to the Public Record Office. They are an essential complement to the magnificent State Papers Domestic already available. Denmark, Flanders, France, German Empire and Hungary, German States, Hamburg and Hanse Towns, Holland, Italian States, Rome and Venice (from PRO Classes SP 75, 77–78, 80–82, 84–85, 94, 99).

## Unpublished State Papers of the English Civil War and Interregnum

This collection is divided into five parts, each illuminating different dimensions of the period and reproducing substantial series of key classes from the public records.

Part 1, taken from PRO classes SP 20, 22, 24 and 28, illustrates the work of parliamentary committees, the most striking innovation in the structure of government introduced by the Long Parliament in the 1640s. The vast bulk of Exchequer papers at the Public Records Office have often deterred scholars from pursuing an in-depth study of finance during the Civil War. Parts Two to Five offer material that makes this important study feasible. How was the Civil War financed? How effective was the Parliamentary regime? What were the implications for the Royalists? How was royal property assessed and disposed? What was done to deal with general social, political and economic dislocations? This collection offers a mass of material with which to answer such questions.

### *Series 1: Manuscript and Typescript Plays*

These plays provide new insight into the nature of drama as a whole and into the workings of British popular theater in the 19th century, both in London and in the provinces where the theater was very much alive.

Frank Pettingell, himself a working actor with a keen interest in the history of his profession, acquired the collection from Arthur Williams, an actor-dramatist of the 19th century. Williams hoarded working texts—in holograph, fair copies, typescript or paste-up--thus accumulating this splendid core of raw material. There are 180 plays, mostly in the author's manuscript, by Colin H. Hazelwood, 1823-75. These allow for examination of the priorities of a house dramatist, later than the almost equally prolific (and almost equally represented) George Dibdin Pitt. This material also offers a unique introduction to the plays of Samuel Atkins, Dion Boucicault (c. 1820-90)--author of the *Colleen Bawn* and an influence upon Sean O'Casey, C. H. Stephenson, Tom Taylor (1817-80)--some-time editor of *Punch*--and numerous others.

Altogether in this little-explored collection there are over 1,000 manuscripts and typescripts--many of them production copies bearing all the trademarks of the working theater. While the Pettingell collection contains volumes dating from the early 18th century and extends into the 20th century (to 1915), it is predominantly comprised of 19th-century material.

### *Series 2: Pantomimes*

The second series of plays in the Pettingell Collection reproduces over 300 pantomime libretti, reflecting the tremendous popularity of this form of entertainment in the 19th century. It is a notable collection covering many theaters and writers: several pieces are extremely rare and are unlisted in Allardyce Nicoll's *History of English Drama*. One of the best-known and prolific authors of Victorian pantomime was E.L. Blanchard, and the collection contains many volumes of the pantomimes produced by him at Drury Lane in the 1870s and 1880s.
