### Aristocracy, the State and the Local Community

*The Hastings Collection of Manuscripts from the Huntington Library, San Marino, California*

Accumulated from more than five centuries of activity in national and regional affairs, the Hastings family papers are a wealth of diverse material for research not only into English history, but also into Irish and Colonial American history. These manuscripts trace -- in remarkable detail -- one of England's longest surviving aristocratic families through the centuries. The correspondence consists of thousands of letters dated from 1477 to 1828. Letters about military affairs, taxation, elections, Jacobite politics, plantations in America, the American Revolution, the Napoleonic Wars, marriages, estate matters, debts and education are contained in this collection, as well as an equally valuable and numerous series of financial papers. These documents illuminate the running of the estate and household from the Middle Ages (the first document is dated 1281) to the 19th century, and include many personal accounts.

## Foundations of Modern Europe

*The Archives of the European Movement: The Concept of European Unity*

The European Movement focused attention on the idea of a united Europe on two levels. Firstly, a united Europe would serve as a call to all shattered communities to unite and rebuild during the post-war period. In addition, a strong and unified Europe would balance the emerging might of the U.S.S.R. The concept of European unity won huge support from the U.S. in both financial and emotional terms: both as a counterpoise to the U.S.S.R. and as a solution to the historic

antagonism between France and Germany. The conversations, correspondence, papers and conferences of influential post-war politicians and diplomats involved with the Movement such as Jean Monnet, Robert Schumann and Paul Henri Spaak gave rise to the European Community in 1952 and laid down guidelines which would shape its consequent course. More importantly, the collection serves to illustrate the emergence of the concept of the European federal model, in contrast to American federalism.

#### *Section 2: Presidential Correspondence and Conversations with Foreign Leaders*

This microfilm publication consists of two subseries of the National Security Advisers Files: Presidential Correspondence with Foreign Leaders, 1974-1977, and Memoranda of Conversations, 1973-1977.

The Presidential Correspondence with Foreign Leaders, 1974-1977 consists of a mix of routine and substantive letters and telegrams exchanged between President Ford and leaders of sixty-four countries. Substantive exchanges address such topics as Angola, the British financial crisis, economic summit meetings, Middle East peace process, OPEC, Cyprus, South Vietnam, NATO, and Soviet influence in Africa and Asia. Supporting materials, including memoranda, notes, and letter drafts, round out the collection. The collection consists primarily of letters, many of them originals, sent by foreign leaders to President Ford and copies of letters and messages sent by President Ford to foreign leaders. Many folders contain supporting materials used in drafting President Ford's letters and telegrams.

The Memoranda of Conversations, 1973-1977 consists of transcript-like records, and the notes from which they were prepared, of President Nixon's and President Ford's conversations with heads of state and foreign officials, senior intelligence and national security officials, American ambassadors, Cabinet members, members of Congress, and other distinguished foreign and American visitors. ## Immigrant in America

Immigrant culture and experience in America have become objects of popular interest in recent years. While many ethnic groups are beginning to acknowledge their various native origins, Americans have developed activities and events honoring the achievements and contributions of their ancestors. However, the phenomenon of immigration has provided a difficult subject of study, owing in part to a serious lack of source material.

Spanning the years between 1789 and 1929, *Immigrant in America* covers two major waves of immigration. In 1820, 10 million people, more than 90% of them from western and northern Europe, entered the country. Among them were the Germans, English, Welsh, Scots, Scotch-Irish, British and Irish, as well as people from Norway, Sweden and France. The second wave, the peak of immigration, took place during the 1880s, ushering in arrivals from eastern and southern Europe: 27 million Poles, Greeks, Italians, Croatians, Ukrainians, Hungarians and Russian Jews. The implementation of the National Origins Act of 1924 effectively ended immigration by 1929.

Adjustment and adaptation were a constant problem for immigrants. Looked upon with suspicion and suffering from a good deal of anti-immigrant sentiment, they were continually subjected to efforts to Americanize them. Many found themselves scapegoats, blamed for social and economic difficulties. To prevent persecution and harassment, many families denied their origins. Only recently have descendants of immigrants elected to assert their backgrounds, calling attention to the contributions of their ancestors. Their struggle to assimilate, despite the threat of ostracism and bigotry, is reflected in this collection.

Not until the New York Public Library began to collect immigrant literature was any serious, systematic effort made to preserve the history of the immigrant. Immigrant colleges, agencies and historical societies gave information that helped piece together a fragmented and elusive history. Under the guidance of A. William Hoglund, Professor of History at the University of Connecticut and Trustee of the Balch Institute for Ethnic Studies, the *Immigrant in America* draws from several major archives, including the New York Public Library collection, to provide scholars with easy access to study sources.

Substantive exchanges address such topics as Angola, the British financial crisis, economic summit meetings, Middle East peace process, OPEC, Cyprus, South Vietnam, NATO, and Soviet influence in Africa and Asia. Supporting materials, including memoranda, notes, and letter drafts, round out the collection. The collection consists primarily of letters, many of them originals, sent by foreign leaders to President Ford and copies of letters and messages sent by President Ford to foreign leaders. Many folders contain supporting materials used in drafting President Ford's letters and telegrams.

The Memoranda of Conversations, 1973-1977 consists of transcript-like records, and the notes from which they were prepared, of President Nixon's and President Ford's conversations with heads of state and foreign officials, senior intelligence and national security officials, American ambassadors, Cabinet members, members of Congress, and other distinguished foreign and American visitors. The memoranda of conversations (memcons) cover a wide variety of foreign affairs and national security topics, including the Middle East peace process, East-West relations, NATO and Europe, normalization of relations with the People's Republic of China, Angola, foreign aid, arms control, energy, foreign economic affairs, investigations of the intelligence community, and more.

## German Baroque Literature: Yale Collection of German Baroque Literature

The von Faber du Faur collection of German Baroque literature was a major acquisition of the Yale Library in the early 1900s. Although the collection was not completely integrated with the library's own Baroque holdings until 1944, it continued to develop and expand until, in 1958, the combined collections totaled more than 1,900 items. At that time the von Faber du Faur bibliography of the collection was published, listing entries by period, subject and author. Within a decade enough new material had been added to the collection -- bringing the total items to more than 2,400 -- to warrant the creation of a supplementary bibliography.

Following the von Faber du Faur bibliography, each volume within the collection has been filmed page by page in the order established by Dr. von Faber du Faur, integrating the works listed in the two volumes into a single sequence.

Few people believed the stories at the time, but then came the ghastly facts of Nazi brutality, revealed by Allied liberating forces. Battle-hardened veterans, inured to the sight and smell of death, were sickened by what they saw. Staggering out to meet them were walking skeletons; their bodies stripped of flesh and their minds rippled by disease and starvation. General Dwight D. Eisenhower recorded that he had "never at any other time experienced an equal sense of shock." He urged Washington and London to send observers to see the indisputable evidence.

This collection provides unique, and never published, documents on the investigation and prosecution of war crimes committed by Nazi concentration camp commandants and camp personnel.

Documents include: correspondence; trial records and transcripts; investigatory material, such as interrogation reports and trial exhibits; clemency petitions and reviews; photographs of atrocities; newspaper clippings; and pamphlets. Documents on several concentration (and later extermination) camps and sub-camps are represented in this new collection, including Mauthausen, Dachau, Belsen-Bergen, Buchenwald, Treblinka, Sobibor, etc.

Mauthausen documents are well represented and include: 33 lists of Mauthausen victims arranged by nationality and compiled by the U.S. 3rd Army from death certificates, notifications of next of kin,

### *Series 3: Henriques Archive*

The Henriques Archive consists of the papers of Lady Rose Henriques who was head of the German Department of the Jewish Committee for Relief Abroad (JCRA). #### Part 2: Bosnia and the Situation in the Former Yugoslavia

This collection consists of materials related to the former Yugoslavia, particularly Bosnia, and presidential decision-making. This collection provides researchers with the opportunity to develop a comprehensive picture of the many issues and the impacts of U.S. policy on the newly-created republics. Issues addressed include diplomatic recognition, humanitarian relief, military intervention, and international negotiations. Documentation consists of cables, NSC materials, press releases, press summaries, news items, and letters from Congress. The press releases originated with such organizations as the White House Press Office, the UN, and AmeriCares (a charitable organization). Many of the press summaries were faxed to the White House by the Republic of Serbia's Ministry of Information. Letters from members of Congress generally urge action of one kind or another in the Balkans and often include supporting material such as newspaper articles or

## Verhandlungen. Stenographische Berichte.

Roughly equivalent to the Congressional Record and the Serial Set in one, this title began in March 1871 and ran through 1933. It is the collected edition of proceedings issued daily during each legislative session of the body which succeeded the Reichstag of the North German Confederation. Each session's debates ("Stenographische Berichte," including question and answer periods and plenary decisions) are accompanied by supplementary volumes with the title "Anlagen." These include legislative bills, reports of committees and party groups, formal inquiries and responses, etc. Most of the Anlagen are numbered with the main volumes (1887-1889/90 also carry separate numbers; 1890/91-1905/06 are numbered separately only). Volumes for 1907-1933 are called volumes 227-458, in a continuous numbering scheme originating with proceedings of parliamentary bodies antedating the German Reichstag, and including both the debates and volumes supplementary to the debates. Volumes 326-458 (1919-1933) relate essentially to the Weimar Republic, and include proceedings of the National Constituent Assembly (volumes 326-343, 1919-1920) which wrote the Weimar constitution.
